Meredith is an attorney specializing in health care litigation. Prior to joining DSR, Meredith was part of a team that represented providers in, among other things, payor-provider negotiations, regulatory proceedings, and administrative appeals. Previously, Meredith volunteered as an attorney for the DMHC Help Center where she resolved complex issues between consumers and health plans.
